

St. Luke's Day School Enrichment Classes for 2017-2018

St. Luke's Day School offers three on-campus afternoon enrichment opportunities for children enrolled in our Threes and PreK classes. These enrichment classes are taught by outside groups; children must be signed up and there is a separate cost. All classes meet in EW116 (Children's Chapel).

Tuesdays: Tae Kwon Do (4:30-5:15 p.m.)

Wednesdays: Ballet (2:40-3:20 p.m. or 3:20-4 p.m.)

Thursdays: Soccer Shots (2:45-3:20 p.m. or 3:30-4:05 p.m.)

Tae Kwon Do, taught by Matthew Langford, builds each child's confidence and character based on a strong Christian philosophy. Children learn to respect themselves and others. Minimum age: 3 ½ (as of 9/1/17)

In **Ballet** classes, offered by Enrichment Services, children learn basic steps and gain a solid foundation in dance. Classical ballet and jazz are taught. Children develop rhythm, balance, flexibility, and grace in a positive atmosphere. Minimum age: 3 (as of 9/1/17)

Soccer Shots is an engaging children's soccer program with a focus on character development.
